

Agreement to Reopen Collective Bargaining Agreement

It is mutually agreed by the following parties, Central Illinois Builders of AGC, Greater Peoria Contractors and Suppliers Association, and the Mid-Central Illinois Regional Council of Carpenters, to re-open the current Collective Bargaining Agreement (but only for the limited purpose(s) stated below) between Central Illinois Builders of AGC, Greater Peoria Contractors & Suppliers Assoc., Inc. and Mid-Central Illinois Regional Council of Carpenters with a term of May 1, 2009 through April 30, 2012 (hereinafter "Collective Bargaining Agreement"), for the sole purpose of extending, without additional modification, the current conditions of the Collective Bargaining Agreement for an additional two (2) year period beginning May 1, 2012 to April 30, 2014, and so as to amend the IAF, pension, welfare and annuity benefit contributions for the additional two (2) year period beginning May 1, 2012 to April 30, 2014.


