### Knox, Warren, SE Corner Mercer County and NW Corner of Fulton County

Article 1. In order to protect the economic standards set forth in this Collective Bargaining Agreement for on-site construction work, it is understood that the Employer shall subcontract work only to a sub-contractor who is signatory to this Agreement, or who shall become signatory to this Agreement. Provided, however, that on signatory type work, such as but not limited to epoxy injection, etc., and where no signatory sub-contractors are available, the above provision shall not apply.

The undersigned parties agree to pay the following wage and fringe benefits listed in Article 17 of the current Agreement as well as the working dues deduction as follows:

### Effective May 1, 2020

### Total package shall consist of:

Base wage, Annuity, Pension, Health & Welfare & Apprenticeship  
 $\$53.98 \times 5\% + \$1.10 \text{ per hour} = \$2.80$

### Deductions

Working dues computed by multiplying the total package  $\times 5\% + \$1.10 = \$2.80$

2 <sup>nd</sup> year	80% Rate =	<b>\$24.42</b>	+	\$23.46 = \$47.88	$\times 5\% + .10\phi$	=	<b>\$2.49</b>
3 <sup>rd</sup> year	90% Rate =	<b>\$27.47</b>	+	\$23.46 = \$50.93	$\times 5\% + .10\phi$	=	<b>\$2.67</b>
