**Effective May 1, 2023 thru April 30, 2024**

the following wages and fringe benefits shall apply

Iron Worker Hourly Wage Rate	- <b>\$35.81</b> per hour
Foreman	- Not less than \$1.90/hr. above scale
General Foreman (15 or more Iron Workers)	- Not less than \$3.00/hr. above scale

Iron Workers Tri-State Welfare Fund	- \$12.11 per hr. worked
Iron Workers Mid-America Pension Fund	- \$ 9.56 per Reg. hr. worked (14.34 OT)
Iron Workers Mid America SMA Fund	- \$ 10.01 per Reg. hr. worked (15.02 OT)
Combined Central Illinois Construction Industry Fund	- \$ .23 per hr. worked
Iron Workers Local 112 Joint Apprentice Fund	- \$ .86 per hr. worked
I.M.P.A.C.T. Fund	- \$ .33 per hr. worked


